- Q: When will a Notice to Proceed be issued?
- A: By April 21, 2025
- Q: When is project scheduled to be completed by?
- A: September 30, 2025, but there are no liquidated damages on this project.
- Q: RTU?
- A: RTU will be installed and powered outside of this contract. This contract will be responsible for connecting to it from underneath. The Mechanical Engineer has verified that our work can occur regardless of the RTU replacement they are independent projects.
- Q: Door Hardware?
- A: All the existing hardware has been supplied by Weavers Locksmith & Keys in Greenville.
- Q: Who is removing and reinstalling cubicles?
- A: The County will do this outside of the contract. The existing power poles are to be salvaged by the EC and reinstalled at the new cubicle locations. See Sheet E3.1 Construction Note #4 and Sheet E4.1 Construction Note #4.
- Q: Existing file room shelving?
- A: The County will remove prior to the start of the project.
- Q: Will employees still be in the space during construction.
- A: Yes. Employees in the East Office Area will still be in perimeter offices during construction. J&FS will work with contractor to allow access to offices for any work with 1-2 days' notice. Employees have the ability to move to other spaces in the building while work in their space is being performed. This is a single-phase project, but coordination will still be required.
