Regarding the reinstallation of the slide gate, the drive gates are TI-IS Trident 2 rail 8'H 12'-14' OPG CNT manufactured by Ameristar of Tulsa, OK. The slide driver is HySecurity SlideDrive, Model 50VF2/3. The salvaged fencing will be reinstalled by the successful bidder, not the owner as stated on Sheet C200. An addendum will be forthcoming with the correction as well as additional fencing information.

16. Site Pavement Subgrade Preperation

Question: Per the Geotech Report, Section 8.2, it states that undocumented fills exist 7-12' deep for site pavement areas. Proof roll operation of prepared subgrade should take place after new proposed building foundations are completed including deep foundations. Soft or yielding soils observed with proof-roll operation should be undercut down to 4' deep maximum, replaced with compacted fill. Then

there are more provisions if these undercuts don't obtain compaction requirements with geogrid and stone backfill, etc. A note states the unit price bid item should be included for this scope of work, I do not believe this is included in the bidding documents. Can the site preparation be clarified in regards to what to include for unsatisfactory subgrades? Possibly an allowance of CY to undercut with stipulation of bringing in compactable materials (hauling off undercuts), or something similar? Then an unit price to utilize if these are encountered in the project?

Question: Can the Bid Item #11 be clarified as to what is expected to be inserted to address the "Additional costs if tariffs are increased"? In the Contract Terms, Item #1, it states that we are to identify cost of tariffs included in bid, which are subject to audit, and any change is bid price due to tariff increase or reduction is subject to RTA approval. It will be basically impossible to accurately provide a cost as to what tariff costs subcontractors and other vendors have added to their bid based on tariffs at time of bid. Also, I am not sure that this bid item #11 is asking for this amount or another amount that could be possibly increased throughout the project duration, which would affect the bid amount and is not something that any bidder would feel confident to quantify. This question is looking to understand more clearly what is expected for tariffs and what this bid item is requesting.

Answered by Noah Greer: Contractors should provide their bid amount as that amount stands on the date of bid submission. If a contractor is aware that there are pending tariff's that have not been officially implemented, then those additional costs should be delineated as an 'additional cost.' For example, as of today, June 4th tariffs on IMPORTED steel and aluminum were increased to 50%. That cost should be included in a bid submission only if an imported product is used. However, there are other proposed tariffs that may come into effect on July 8th, after the date of bid submission and those costs, if known, should be listed as an 'additional cost.'

Answered by Noah Greer: Please disregard the federal clause stating a minimum bond of 5%. The State of Ohio requirements are stricter so those are what should be followed for this project. The official requirement from the Ohio Revised code can be satisfied one of two ways, as stated in the letter to bidders in the beginning of the bid package. "In accordance with the drawings and specifications on file at the Greater Dayton Regional Transit Authority (RTA). Pursuant to Section 153.54 et seq. of the Ohio Revised Code, the bidder shall submit a Bid Guaranty in the form of either: 1. A bond for the full amount of the bid conditioned that if the bid is accepted, the bidder after the awarding or the recommendation for awarding the contract, will enter into a proper contract based upon the bid; or 2. A certified check, cashier's check, or letter of credit pursuant to Chapter 1305, Ohio Revised Code, in the amount of 10

percent of the base bid amount." This means that bidders can decide to give a bond for 100% of the bid amount OR a certified check for 10% of the bid amount.
